## Seller and Buyer Further instructions

### The Seller must:

- a) Complete a separate transfer form for each Buyer (If more than one buyer).
- b) Complete the details required in full on the Share Transfer Form.
- c) Include the share identification number as detailed in the share notification letter.
- d) Ensure that all signatures are witnessed in full. The transfer form must be signed by the Seller(s), dated and witnessed. All joint holders must sign. If the form is being signed under a Power of Attorney, the Power of Attorney must be provided to the share registry along with a non-revocation of Power of Attorney.
- e) Complete the Seller's section of "Further Questions" above.

### The Buyer must:

- a) Complete the details required in full and sign as Buyer.
- b) Advise HWP Ltd of any and all land holdings within the command area, including any land being purchased that has initiated the share transfer.
- c) Attach a copy of the recent rates notices, clarifying land ownership.
- d) Ensure that all signatures are witnessed in full. The transfer form must be signed by the Seller(s), dated and witnessed. All joint holders must sign. If the form is being signed under a Power of Attorney, the Power of Attorney must be provided to the share registry.
- e) Complete the Buyer's section of "Further Questions" above.

### Important notes:

- Note that under Section 92 of the Companies Act 1993, securities may not be registered into the name of a Trust (unless it is a Registered Charitable Trust, and documented evidence is produced to our office for noting). In the case of other trusts, shares must be registered in the name/s of the trustee/s. The word 'Trust' must not be used in any part of the registered name or address.
- By completing this form, the Buyer and Seller authorise HWP Ltd to use the following information from this form for the purpose of disclosing share sale transaction information on its website: share sale date, the number of shares sold and the price paid. This information will be anonymous and will not identify the individual names of Sellers or Buyers."
